- ◆ Guest Speakers: Call your DGs, DRFCs, AGSCs, and/or club presidents and let them know you and your zone team members are available to speak at district Foundation seminars, conferences or clubs in your zone. Ask Foundation alumni or a beneficiary of a Humanitarian Grant project in your districts if they would be interested in speaking at a district or club event.
- Recognition: Encourage clubs and districts to recognize Major Donors, Bequest Society members, Paul Harris Society, Paul Harris Fellows, and Rotary Foundation Sustaining Members during this important month
- Non-Contributing Clubs: Contact those clubs that have not yet made a contribution to The Rotary Foundation and ask that they consider doing so this month.
- Publicity: Publicize the great works of the Foundation in local newspapers, radio, and cable TV stations by highlighting newsworthy programs that your districts have supported. Local media often looks for compelling stories to tell. Why not tell your Rotary story?

## Giving Reports: Zone 34

Our Annual Programs Fund **goal for 2009-2010 is \$3,936,246** At the end of the fist quarter of this Rotary year, Zone 34 Rotarians have donated \$585,415.

### In Memoriam

We are sad to report that **Astra Da Costa, District Governor of Rotary District 7030,** died October 15 of complications related to the H1N1 flu virus. Astra was the executive chairman of Port of Spain company, Ample Advertising, and the chairman of the Queen's Hall board of directors. She was the first woman to lead this district that spans part of the Caribbean



and the northern tip of South America, and she was a Level One Rotary Foundation Major Donor..

Astra joined the Rotary Club of Central Port of Spain, Trinidad in 1995. From her biography on the District 7030 website, we learn that Astra played a key role in revitalizing her club, raising attendance levels and participation in the club's various projects. Astra's term as President saw the club establishing an Emergency Medical Relief Fund to underwrite surgery and medical treatment for underprivileged youth; enhancing its Adopt-a-Child Program allowing an increased number of students to receive school books; expanding the reach; securing extended support and funding for its Model United Nations Assembly (MUNA) project through the Ministry of Education and major corporate sponsors.

In 2004, Astra served as Trinidad and Tobago's Rotary Disaster Chair, supporting Clubs' response efforts, securing and shipping donations to the island, and spearheading a fundraiser dedicated to assisting with rebuilding one of Grenada's major Secondary Schools. At the District level, she has been a facilitator on the District Training Team since 2002, speaking at PETS, Assembly and Conference and at training sessions for Assistant Governors on Public Relations, Rotary's Image, Time Management and Club Administration. She has served as Assistant Governor, District Public Relations Chair, GSE Chair, Faculty and Public Relations Officer of RLI.

Astra was founder or the Ample Advertising Agency. Her Business partner Alfred Aguiton said, "Her contribution was in most respects unparalleled and covered a range of social and corporate responsibilities. She turned out to be a paragon of professionalism and I don't know anyone who could have been a better partner in the profession."




### Take Me Out to the Ball Game


positive comments were made about the seminar's educational value and opportunities for fellowship.




- Past RI Director Ken Morgan came from North Carolina to make a compelling presentation about the impact of large gifts to support the good work of TRF

## Test Your Foundation Knowledge: What Are Donor Advised Funds?

# A Way to Fulfill Philanthropic Goals and Support The Rotary Foundation!

The Rotary Foundation donor advised fund is a convenient way to simplify your charitable giving and take advantage of tax savings at the same time. A donor advised fund account is similar to an investment account earmarked exclusively for charitable giving. It allows you to make contributions and grant recommendations to the Foundation and other preferred charities at your convenience.

In many ways, it's like having your own foundation to support your favorite causes, but without the hassles and paperwork. Individuals or a married couple (Individual accounts can have a maximum of two account holders.) or a Rotary-affiliated group can establish a donor advised fund account with The Rotary Foundation for a minimum, irrevocable contribution of \$20,000 or more.

### Donor advised fund accounts offer these benefits:

- Support to The Rotary Foundation and other preferred charities
- ♦ Immediate tax benefits
- Professional asset management
- Flexibility to make <u>grant recommendations</u> suited to your timetable
- ♦ Easy record-keeping and tax reporting
- Bequest Society membership for individual donor advised fund account holders
- ♦ No start-up fees

### **How the Donor Advised Fund Works:**

- Individual(s) or a Rotary-affiliated group (e.g., the Rotary Club of Anytown, USA) makes a minimum initial contribution of US\$20,000 in cash or securities and receives an immediate tax deduction.
- Accountholders may recommend how the contribution will be allocated among four available investment portfolios
- ◆ Individual(s) or a Rotary-affiliated group recommends when and how much to grant to other IRS-approved charities. Each year, The Rotary Foundation's programs benefit from an annual grant distribution to the Annual Programs Fund. "Individual" DAFs will eventually create a lasting legacy with the Foundation's Permanent Fund.

### **Donor Advised Funds are appropriate for Rotarians who:**

- Wish to support The Rotary Foundation and other favorite charities
- Want to maximize their tax deductions, especially in years when offsetting tax liabilities is especially desirable
- Own highly appreciated securities, restricted stock, or privately held stock
- Are concerned about managing the paperwork and tax reporting associated with operating a separate foundation
- Are looking to incorporate charitable giving into estate planning
- Want their charitable dollars professionally managed

### Zone 34 2010-11 Foundation Seminar: Save the Date!

Incoming RRFC Brent Williams has been working closely with Zone 34 RIMC Jim Henry, and they have set the dates for the 2010 Rotary Foundation Seminar and Membership Seminar. The inclusive dates of the seminars are Monday, May 24, 2010 through Wednesday, May 26, 2010.

Response to the Zone Foundation Seminar held last June was overwhelmingly positive, as was feedback on linking the Foundation and Membership Seminars, so that district leaders can easily and conveniently attend both seminars. Based on the strong consensus of attendees, representing all 14 districts in Zone 34, we will keep the seminar in Evanston.

Attendees also made many positive comments about the Evanston Hilton Garden Inn as the seminar venue. RRFC Rich Panyik did a great job in planning and implementing the 2009 seminar. He had strong support from TRF management and staff members, who made themselves available to participate as presenters and resource personnel. Incoming RRFC Brent has had conversations with key TRF personnel, who have assured him that same cooperation and participation will continue with the venue remaining at Hilton Garden Inn.

The order of the seminars will flip in 2010. Jim will truncate the schedule for the Membership Seminar, and it will last one full day on Monday. We will still have a joint banquet for attendees of both seminars as we have done so the past couple of years, and the banquet will be Monday night. The Foundation Seminar will then begin Tuesday morning, continue throughout that day, and then will conclude with a half-day session on Wednesday. Brent will set the agenda so that the meetings conclude by 11:30 AM, so that everyone will be able to catch flights home that afternoon.

Everyone traveling to Evanston to attend both the Membership Seminar and the Foundation Seminar should arrive by Sunday evening, May 23 and make plans to remain in Evanston until Wednesday afternoon. Those coming for just the Foundation Seminar should arrive by Monday afternoon, in order to be able to attend the banquet that evening.

Brent will send out more details as they emerge, but he wanted you to mark your calendars now for these seminars.

## Polio Eradication and the \$200,000,000 Challenge ...

## World Polio Day: October 24

Rotarians worldwide will recognize World Polio Day and the late Dr. Jonas Salk, developer of the world's first safe and effective polio vaccine. Poliomyelitis, finally on the verge of eradication, has been one of the most feared diseases of the last century. At that time, polio crippled or killed over 500,000 people, mostly children, annually.



In 1985 Rotary International made a promise to the children of the world to eradicate polio. We engaged important partners in the World Health Organization, UNICEF, and the Centers for Disease Control and Prevention. Together, since that time, we have eliminated polio from most of the world.

Today, 4 countries, Pakistan, Afghanistan, India, and Nigeria, remain endemic. We still have work to do around the world—vaccine to give, monitoring to ensure the disease doesn't come back. And money to raise to meet the Bill and Melinda Gates Foundation Challenge. Keep thinking about how you can help us make a difference.
