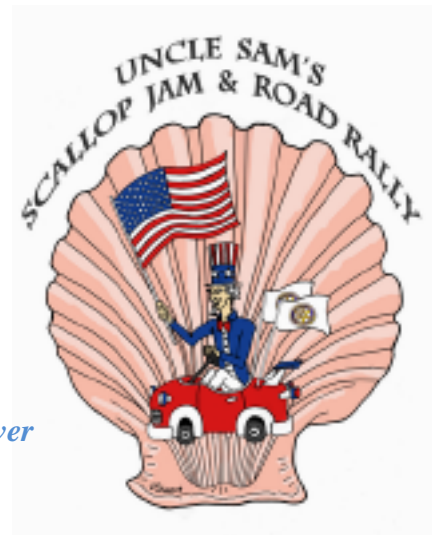

Application fees: An application and release form must be accompanied by a check for \$50.00. Electronically submitted applications will be processed upon receipt of payment. Space is limited, so apply early. Make checks payable to The Rotary Club of Crystal River. Applications will not be considered unless completely filled out and accompanied by the fee. There are a limited number of corner spaces for this year's event.

Any NSF checks will not be re-deposited, a money order or cashier's check will be needed with the NSF bank fee of \$30.00

Deadline: The absolute final deadline for entries is June 20, 2011. We cannot control the weather. The show will be held rain, shine. No refunds will be made.

Security: All exhibitors should take personal responsibility for securing all valuables, and personal items. Please note that the Rotary Club of Crystal River and The City of Crystal River is not responsible for any losses, damages or claims for personal injury or property damages whatsoever during the duration of the festival. We ask that you plan on vacating the show grounds after the show concludes Saturday evening.

Exhibit spaces are approximately 12' x 12'. No sharing of spaces is permitted. Gas powered generators are allowed please let us know on your application if you plan to use one. Some electricity is provided. No pets allowed, with the exception of guide or service dogs.

Each exhibitor is responsible for collecting Florida sales tax and remitting it to the Department of Revenue.

Registration will be at the Seminole Club, 135 NE 3rd Street, Crystal River, on the corner of NE 3rd Street and NE 2nd Ave. Each 12' x 12' space will be assigned a number and the numbers will be issued to exhibitors at check-in. Registration time is 2:30 P.M. Each exhibitor is expected to have his/her display ready by 4:00 P.M.

No break down before 10:00 P.M. Strictly enforced. Streets are Lighted

Booth numbers will be given at the time of registration. Artist & Crafter's cannot move location without the express permission from the Rotary Club of Crystal River. Courtesy to ALL is an absolute must. No rude or vulgar behavior or disturbances will be tolerated. Any questions or concerns can be addressed to the Event Chairman.

Artist and Crafter's are responsible for keeping their spaces clean at all times. We appreciate your cooperation in keeping our city clean.
